

### Verification of Distribution

VERIFIED conducted a field verification survey to provide standard, objective measure of the receipt of **East County Observer** within its stated delivery area.

Enough locations were successfully confirmed to have received the publication to establish regular receipt of the **East County Observer**.

### Methodology

On August 17, 2019 VERIFIED conducted a random, representative field verification of households within the block groups throughout the circulation area of **East County Observer**.

Quarterly updates of the route lists are maintained by VERIFIED as a reference.
